Maximum value: under \$1,000. per artwork is subject to DAL committee approval. All artwork in this exhibit must remain for the duration of the show. Anyone removing their art will be prohibited from entering future shows, unless authorized by the DAL committee. Please note DAL artists are not allowed in gallery when exhibit is being hung or judging is taking place. No nudes, violent image, or political content will be displayed. Each artist must sign the Waiver of Liability prior to displaying their artwork. **ORIGINAL ARTWORK ONLY! NO PRINTS OR GICLEES!**

### ELIGIBLE WORK:

All artwork must be no larger than 40"x 40" (including frame), properly framed (plexiglass only), or gallery wrapped (no staples showing on the canvas sides) wired and ready to hang. Wire should be placed on the upper third of frame to hang close to the wall or rack grid. All artwork must be labeled (on the back upper right hand corner) with artist's name, title, address, medium and price PRIOR TO DELIVERY. PLEASE SEE RULES FOR INDOOR SHOWS IN THE DELRAY ART LEAGUE DIRECTORY.
