

## DELRAY ART LEAGUE INDOOR SHOW RULES (Updated 2021)

Members will be advised at general meetings and in the DAL Newsletter of upcoming indoor shows.

Exhibitors must be Basic Members or Premium Members and their dues must be current.

**All artwork will be juried into each show, and is subject to DAL committee approval.**

2D or 3D artwork must be original - no reproductions (giclees, prints, or copies, etc.).  
Artwork must be no larger than 36 inches in any direction including the frame.

Maximum value per artwork must be under \$999.99.

Artwork must be properly framed (**plexiglass only, no glass**) or gallery wrapped (no staples showing on the sides).

PRIOR TO DELIVERY, artwork must be wired and ready to hang (no sawtooth or other hangers).  
Wire should be placed on the upper third of frame to hang close to the wall or rack grid.

PRIOR TO DELIVERY, artwork must have a label attached to the back upper right-hand corner including your name, address, phone number, title of artwork, medium, size and price.

**Not Acceptable Categories** (except those grandfathered in): Nudes, political themes, violence, crafts, bead-stringing, poured molds, flowers, shell craft, etc. Categories not listed will be decided at the discretion of the Jurying Committee, with final determination by the Board of Directors.

**NO CHANGES ALLOWED TO SUBMITTED AND ACCEPTED ENTRIES.**

Delivery and pick up times must be adhered to. If an exhibitor is late delivering their artwork, the artist will not be permitted to enter the show. Members must deliver and pick up their own artwork unless a signed note by the artist accompanies the person delivering or picking it up. If an exhibitor has not picked up their artwork when the exhibit closes, the artist will be charged a \$ 25.00 storage fee.

**Artwork must remain for the duration of the show. Anyone removing their art (without permission) will be prohibited from entering future shows for the remainder of the season and/or the following season.**

Exhibitors are not allowed in the gallery when the exhibit is being hung or judging is taking place.

Delray Beach City Hall and Sugar Sand Park, or The Delray Beach Chamber of Commerce are not responsible for any artwork shown within their buildings.

Failure to abide by the rules shall result in termination of exhibiting privileges for a period of time imposed by the Board in accordance with procedures set forth in the DAL By-Laws.

**REMOVAL OF ARTWORK FROM ANY SHOW WITHOUT THE CONSENT OF A DELRAY ART LEAGUE REPRESENTATIVE IS PROHIBITED.**

### **For City Hall Shows:**

The City Commission has the authority to deny or request the removal of any exhibit that it does not deem to be appropriate. Nude subjects, political themes and violent subjects are not permitted.

Artwork may not be priced or sold on City premises, but information may be posted in the exhibit area so that interested buyers may contact the artist.

Exhibitor understands and agrees that the City of Delray Beach and the Delray Art League shall have no responsibility for the care and safekeeping of any exhibit piece and any loss or damage shall be the sole responsibility of Exhibitor. In consideration of the City allowing the Exhibitor to exhibit his/her works of art in City Hall the Exhibitor shall indemnify and hold the City of Delray Beach and the Delray Art League harmless against any and all suits, actions and claims including attorney's fees and costs attendant to any claim, litigation, administrative proceeding, appeal and judgment of every name and description brought against the City of Delray Beach or the Delray Art League as a result of this exhibit.
